## Economic Impact of the Missouri Nonprofit Sector

- Employs **230,900** - 10.8% of the state's workforce
- Generates **\$46.3 billion** in annual revenues
- Holds assets of **\$86.5 billion**
- Missouri foundations annually give over **\$784 million**
- Missourians give over **\$2.8 billion** to charity each year, representing **4.4 percent** of household income

### Deliver vital community services

The United Way of Central Missouri and the Community Health Center of Central Missouri provided affordable primary care services to 3,417 patients in 2009. These include medical, dental and mental health services, and are available to residents in Cole and Osage counties.

### Give voice to the people they serve

The Missouri Association for Community Action, a member of the Community Initiatives Network, is a statewide association of 19 community action agencies fighting poverty in every county in Missouri. MACA provides training and advocacy to promote policies that fight poverty. In 2009, MCA's Legislative Day brought Community Action volunteers and partners from around the state to meet with legislators and raise awareness about poverty in Missouri.

### Contribute to vibrant communities

The Mission Continues helps returning veterans continue their service to the United States as citizen leaders. Based in St Louis, the Mission Continues has awarded fellowships with nonprofit organizations to over 80 wounded or disabled veterans nationally, and 11,871 veteran volunteers have participated in service projects.

### Advance solutions for challenges facing society

The Ewing Marion Kauffman Foundation's Kansas City fund supports programs that promote culture and civic welfare in the city. In 2008, they awarded over \$10 million to organizations such as the Black Archives of Mid-America and the Kansas City Public Library.

*Note: The “nonprofit sector” encompasses organizations that are defined as tax-exempt under section 501(c) of the Internal Revenue Code. This includes both public charities and private foundations [501(c)(3)] and other nonprofits such as civic league organizations [501(c)(4)]. Exceptions are noted when relevant.*
