## Public Charities and Foundations Benefit Idaho Communities

### Deliver vital community services

The Cascade Division of the Salvation Army serves the hungry, homeless, and impoverished throughout Southern Idaho and Oregon, providing more than 125,000 nights of lodging and 493,000 meals to needy residents in 2012. In addition to its anti-hunger initiatives and disaster preparedness programs, the Council conducts enrichment services for seniors and youth.

### Give voice to the people they serve

Established in 2010, the Anna Schindler Foundation is dedicated to raising money for families whose children have been diagnosed with cancer and to fostering awareness of the disease. In addition to donating \$24,000 in meal cards to patients at Sacred Heart Children's Hospital in 2013, the foundation distributed thousands of dollars directly to area families for medical bills, groceries, and travel during the treatment process.

### Contribute to vibrant communities

Headquartered in Boise, the youth leaders involved in the Ore-Ida Council of the Boy Scouts volunteered nearly 150,000 service hours in 2013, including a food drive that collected over 151,000 pounds of food for area residents. Among the 12,800-plus merit badges earned that year were 457 new Eagle Scout awards.

### Advance solutions for challenges facing society

Celebrating its 30th season in 2014, the Sun Valley Summer Symphony broke records the previous year, bringing the joys of classical music to over 6,000 attendees who gathered in Idaho for the energy-filled events. Committed to outreach, the Symphony also provides music education and performance opportunities to area students of all levels, including 2,336 hours of instruction in 2013.

## Economic Impact of Idaho Nonprofit Sector

- Employs **54,305** - almost 8.4% of the state's workforce
- Generates more than **\$5.06 billion** in annual revenues
- Holds assets of almost **\$8.99 billion**
- Idaho foundations annually give almost **\$89 million**
- Idahoans give **\$915.9 million** to charity each year, representing **4.2 percent** of household income
