The Cascade Division of the Salvation Army serves the hungry, homeless, and impoverished throughout Southern Idaho and Oregon, providing more than 106,337 nights of lodging and 768,380 meals to needy residents in 2018. In addition to its anti-hunger initiatives and disaster preparedness programs, the Council conducts enrichment services for seniors and youth.

Established in 2010, the Anna Schindler Foundation is dedicated to raising money for families whose children have been diagnosed with cancer and to fostering awareness of the disease. In 2017, the Foundation began building Anna's Homes, an initiative to provide out-of-town families receiving treatment at Sacred Heart Children's Hospital with a safe and peaceful home.

Headquartered in Boise, Ore-Ida Council Boys Scouts of America provides high quality programming to more than 14,500 youth and their families in Southwest Idaho and Eastern Oregon.

Advance solutions for challenges facing society

The mission of the Sun Valley Music Festival is to perform exceptional, free-admission classical music concerts that inspire and enrich lives through dynamic, engaging artistic programming and to provide music education programs for youth and adults. Committed to outreach, the Symphony also provides music education and performance opportunities to area students of all levels, free of charge.
