As a member of the charitable community, I am writing to encourage you to advocate for the inclusion of the *Universal Giving Pandemic Response Act* in the next COVID-19 relief package. The pandemic and the economic downturn have severely damaged charitable giving in America. Despite a few bright spots and big headlines, the latest data shows a troubling decline in donations this year with an 11 percent drop in March alone. At the same time, demand for charitable services has skyrocketed.

Senators Lankford (R-OK), Coons (D-DE), Lee (R-UT), Shaheen (D-NH), Scott (R-SC), and Klobuchar (D-MN), as well as Representatives Walker (R-NC) and Pappas (D-NH) have introduced the Universal Giving Pandemic Response Act, legislation that would significantly increase the cap on the universal charitable deduction for 2020. Independent Sector-commissioned research indicates that such a proposal could unlock over \$17 billion in new giving per year if made permanent.

But this critical lifeline for our communities will only be cast if legislators hear from the people they represent.
