Deliver vital community services

Empire Health Foundation boldly advances health equity in eastern Washington and beyond. \$320 million have been leverage by the Foundation and its partners from 2011-2018. Since its inception, the Foundation has worked on key health issues including preventing childhood obesity. As of now, they've reached 61% of schoolage children in eastern Washington, and are reversing Washington's childhood obesity trend by demonstrating a 12% reduction in overweight/obese students. Give voice to the people they serve

Marguerite Casey Foundation's work focuses on creating a national movement of families advocating for poverty alleviation. In partnership with 250 grantee organizations in 12 states, the Foundation held a series of 65 town hall meetings to aggregate the voices of some 50,000 families into a national platform of values and concrete policy suggestions, culminating in the National Family Platform.

Contribute to vibrant communities

Seattle Goodwill, a mission-driven organization, works to address poverty and strengthen communities by preparing people for employment in the current and future marketplace. In 2018, Seattle Goodwill served 13,375 students and helped place 1,720 individuals in jobs. Advance solutions for challenges facing society

Based in Seattle, the Bill & Melinda Gates Foundation adds \$1.5 billion to the local economy every year. Their Washington State strategy supports all students where they live, learn and play-at home, at school, and in their neighborhoods.

They helped build nearly 1,500 units of transitional housing, and continue to support new and cost-effective ways to address and prevent homelessness.

Economic Impact of Washington Nonprofit Sector

- Employs 259,427 over 9.7% of the state's workforce
- Generates more than \$64.6 billion in annual revenues
- Holds assets of \$208.8 billion
- Washington foundations annually give over \$4.5 billion
- Washingtonians give **\$4.4 billion** to charity each year, representing 3.08 percent of household income
