**We are the national membership organization that connects, strengthens, and advocates for nonprofits and philanthropies.**

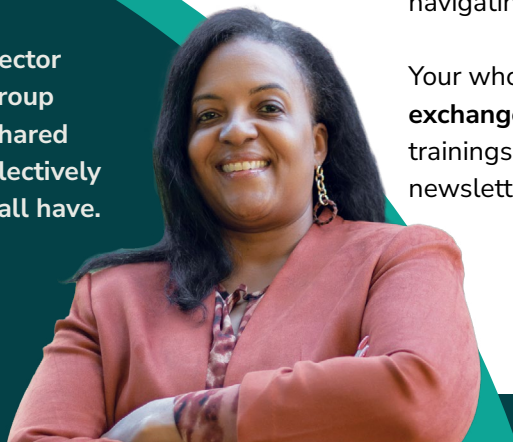
We unite nonprofits and philanthropies as a single charitable sector. Together with our member organizations, we drive policies and solutions to strengthen our sector and its impact.
